Client will select among the candidates along with background and referral information provided by The Nanny Connection, Inc and Client will make the sole hiring decisions.

The Nanny Connection, Inc. will meet with your family to discuss the needs and qualifications you would like in your nanny. From there the agency will provide candidates who have been interviewed by the agency to the Client. The agency will also provide three verified references, a criminal background report, and social security verification for selected candidates. The agency can also provide Department of Motor Vehicle report and fingerprint report should the Client request. The Nanny Connection, Inc. does use third party companies to verify these reports and cannot guarantee the accuracy of this information, but will provide you with all the information we collect on the candidates. The client does agree to keep all identity and hiring documents confidential for all candidates they interview.

The Nanny Connection, Inc. is a referral agency only and not an employer nor independent contractor with the Client and therefore assumes no liability or responsibility for the nanny once the client has hired them. The client unconditionally releases The Nanny Connection, Inc. and its employees, directors, owners, and recruiters and shall not hold The Nanny Connection, Inc and its employees, directors, owners, and recruiters liable for any personal property damage, losses, injuries, or expenses incurred by the Client once they have selected and hired their nanny. Client further agrees that they will indemnify and hold The Nanny Connection, Inc and its employees, directors, owners, and recruiters harmless for any resulting liability or expense including court and legal fees incurred in defending against the employed or formerly employed nanny they hired.

Client agrees to pay the \$150 nonrefundable start-up fee to begin the process of The Nanny Connection, Inc. finding referred nannies to the Client. The start-up fee will go towards the final amount due at the end of the search once the Client has hired a nanny and is good for one calendar year from signing date. All placement fees are due at the time of placement when Client has officially hired their chosen nanny. If within 60 days of placement, the nanny should leave or client terminated nanny for any reason, The Nanny Connection, Inc. will refer additional candidates until a replacement is found at no additional cost. The Nanny Connection, Inc. will only offer one free nanny replacement from 60 days of placement. The Nanny Connection, Inc. will keep a valid credit card on file for the client and shall charge the card at the time of placement, if placement fees are not received yet. **The Nanny Connection, Inc. will not start any referral process until they have a valid credit card on file along with the start-up fee paid in full.** The placement fees are as follows:

36HRS+ WEEKLY: 12% FINDERS FEE OF ANNUAL NANNY SALARY OR MINIMUM \$1500

15-35HRS WEEKLY: 15% FINDERS FEE OF ANNUAL NANNY SALARY OR MINIMUM \$1000

NANNY YEARLY SALARY TO BE NEGOTIATED BY YOUR FAMILY WITH HELP FROM PLACEMENT AGENT

The signing of this form agrees to all of the above as well as the agreement to charge the credit card on file for any fees not paid at the time of placement. Client further agrees that in the event The Nanny Connection, Inc. must seek collections for unpaid fees they client will be responsible for all collection costs, court costs, legal fees, and attorney fees along with interest of 1.5% per month until paid.
